Minimum Charges for Specific Administrative Actions Taken in Israel

1. Response to an official action under Section 18 of the Patents Law:
Minimum \$ 350
2. Section 18 update before final approval of a patent application:
Minimum \$ 275
3. Payment of the publication fees (including official fees) of a patent:
Minimum \$ 600
4. Review and forwarding the Patent Registration Certificate:
Minimum \$ 100
5. Completing issue formalities and transmitting the Trademark Registration Certificate:
Minimum \$ 175

Minimum Charges for certain actions taken abroad

1. There is a 25% surcharge on all charges and fees of our foreign associates, including associate's fees, official fees and expenses in respect of filing patent, design and trademark applications, the continued prosecution of the applications through to registration and renewals.

2. Foreign Applications:

Patents:

- I. Our charges for the filing of a patent application in any country other than Europe are no less than \$500 per application in addition to charges and fees of our foreign associates as described above.

Our charges for the filing of a patent application in Europe are no less than \$1,000 per application in addition to charges and fees of our foreign associates as described above.

However, if our associate's charge for the filing of a patent application in a single country (other than Europe and Japan, to which this section does not apply), exceeds the amount of \$8,000, our office will charge only \$2,000. This restriction refers to the filing of the application only, and not to the actual writing of the patent application or its prosecution.

- II. Our charges for the filing of a PCT application are \$2,000 not including official fees which are charged according to the actual cost.

Designs and Trademarks:

Our charges for the filing of a design or trademark application outside of Israel are no less than \$400 per application in addition to charges and fees of our foreign associates as described above.

III. Renewals outside of Israel of patents, designs and trademarks:

Our charges for renewals are no less than \$100 in addition to charges and fees of our foreign associates as described above.
